**Official Rules**  
**Nevada Prepaid Tuition Referral Program**  
**Deadline: April 15, 2026**

1. **The Nevada Prepaid Tuition Referral Program rewards both referrers and referees with a \$100 Visa Electronic Gift (E-Gift) Card each when a successful referral is made during the 2026 Open Enrollment Period, which runs from November 1, 2025 through April 15, 2026.**
2. **Sponsor:** The College Savings Board of Nevada is the sponsor of this Nevada Prepaid Tuition Promotional Referral Program.
3. **Eligibility Requirements:** The Nevada Prepaid Referral Program begins on November 1, 2025, and closes at 11:59 p.m., on April 15, 2026. All participants must be 18 years of age or older. Referrers, or those providing the referral codes, must be current or past Nevada Prepaid Tuition (NPT) account holders, legal successors, or qualified beneficiaries. Only individuals with a history of holding a NPT account will be issued a referral code via email from [NVPrepaidReferral@NevadaTreasurer.gov](mailto:NVPrepaidReferral@NevadaTreasurer.gov). **Canceled accounts are not eligible.** Individuals without a NPT account history **will not** qualify to receive a referral code. Referees, or those using the referral code, must open a new Nevada Prepaid Tuition contract during the 2026 Open Enrollment period by Wednesday April 15, 2026, at 11:59pm PT and complete their first month's payment, on or before May 15, 2026, to be eligible for the reward. Sponsor reserves the right to verify eligibility at any time, and reserves the right not to award prizes to ineligible applicants
4. **How to Enter:** To participate in the Nevada Prepaid Tuition Referral program, eligible referrers will receive a unique 7-character referral code via email by [NVPrepaidReferral@NevadaTreasurer.gov](mailto:NVPrepaidReferral@NevadaTreasurer.gov). The referrer must provide their referral code to the referee. The referee must provide that code in Section I on their enrollment form during the 2026 Open Enrollment Period. Referrals submitted without a valid referral code at the time of enrollment will not be eligible for the reward. Neither the Nevada Prepaid Tuition Program, nor the State of Nevada Treasurer's office, nor the College Savings Board of Nevada assumes any responsibility for lost, stolen, late or damaged Enrollment forms.
5. **Rewards:** For each eligible referral, both the referrer and the referee will each receive a \$100 Visa E-Gift Card. Gift Cards will be emailed to the email on file after the open

enrollment period concludes and after the referee's first month's payment has been verified. There is **no limit** to the number of referrals a referrer may partake in. However, each referral must meet all eligibility requirements to qualify for a reward. Funding for the Nevada Prepaid Tuition Referral Program will be provided by the College Savings Board of Nevada through the Nevada Higher Education Prepaid Tuition Trust Fund.

- All participants are urged to consult a tax advisor regarding tax consequences of any reward based on their own individual circumstances. All rewards will be awarded. Rewards not claimed within thirty calendar (30) days after the date on which the notification was made will be forfeited and be returned to the Nevada Higher Education Prepaid Tuition Trust Fund. All rewards are awarded "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

- 6. Distribution:** Referral rewards will be distributed in the form of \$100 e-gift cards, which will be delivered electronically via email to the email address on file for both the referrer and referee. E-gift cards will be issued only after the close of the open enrollment period and confirmation that the referee has successfully completed the first month's payment. The Nevada State Treasurer's Office or staff, the College Savings Board of Nevada, the State of Nevada, the Nevada Higher Education Prepaid Tuition Trust Fund are not responsible for incorrect, incomplete or outdated email information provided by participants, or for lost delayed, misdirected, or undeliverable electronic communication.
- 7. Privacy Policy:** Any information provided to The Nevada State Treasurer's Office through participation in the Nevada Prepaid Tuition Referral Program is used only in accordance with the State of Nevada Treasurer's Office Privacy Policy, as amended from time to time, currently located in the 2026 Nevada Prepaid Tuition Program Description and Master Agreement, which can be accessed at [NVPrepaid.gov](http://NVPrepaid.gov).
- 8. General Terms and Conditions:** This Nevada Prepaid Tuition Referral Program is void wherever prohibited or restricted by law. By participating in this Nevada Prepaid Tuition Referral Program, all participants agree to be bound by all the Official Rules of this Nevada Prepaid Tuition Referral Program and the decisions of the Sponsor, which shall be final. All federal, state, and local laws and regulations apply. Neither the Sponsor, nor the State of Nevada Treasurer's Office, nor the College Savings Board of Nevada, nor any other State of Nevada employee, is in any way responsible or liable for damage, loss or injury resulting from human error, altered, illegible, late, lost, or misdirected applications, events beyond their control, or acceptance and use of the reward. Participants assume liability for injuries caused or claimed to be caused by participating in the Nevada Prepaid Tuition Referral Program or by any reward. Sponsor reserves the right to suspend or terminate the Nevada Prepaid Tuition Referral Program or any entrant's participation in the Nevada Prepaid Tuition Referral Program should unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper payout of the Nevada Prepaid Tuition Referral Program, or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Nevada Prepaid Tuition Referral Program as planned. Participants who violate

these Official Rules, tamper with the operation of the Nevada Prepaid Tuition Referral Program or engage in any conduct that is detrimental or unfair to Sponsor, the Nevada Prepaid Tuition Referral Program or any other individual (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Nevada Prepaid Tuition Referral Program. Sponsor reserves the right to lockout any Participant whose eligibility is in question, has been determined to be incapacitated due to death or other circumstance, or who has been disqualified or is otherwise ineligible to enter the Nevada Prepaid Tuition Referral Program. Capitalized terms used herein and not defined in this document shall have the meanings defined in the 2026 Nevada Prepaid Tuition Program Description and Master Agreement.

9. **Certificate and Consent:** By entering, participant agrees that no claim relating to losses or injuries shall be asserted against the Nevada State Treasurer's Office, the College Savings Board of Nevada, the State of Nevada, the Nevada Higher Education Prepaid Tuition Trust Fund, or any of their affiliates, directors, officers, shareholders, employees, or agents. By accepting a reward, Participants agree to and shall be deemed to release and hold harmless the Nevada Higher Education Prepaid Tuition Trust Fund, the College Savings Board of Nevada, the State of Nevada Treasurer's Office or staff, and any other employee of the State of Nevada against any and all losses, damages, rights, claims and actions of any kind resulting from or arising in connection with the Nevada Prepaid Tuition Referral Program or acceptance, delivery, mis delivery, possession or use of or inability to use any reward, including without limitation, personal injuries, death and property damage, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional, and whether under a theory of contract, tort theory (including negligence), warranty or other theory.
10. **Use of Information:** With written permission from the Referrer or Referee, Sponsor may use their name, city of residence, photo, video, and any testimonial in marketing, outreach and promotion of the Nevada Prepaid Tuition Program.
